EXPLANATION:

In accordance with the fourth paragraph of Article 13 of the Capital Market Law No. 6362, the shares of our Bank and investment fund participation units that were not dematerialized within the prescribed timeframe and whose ownership was transferred to the Investor Compensation Center ("YTM") are being refunded and paid to the rights holders by the YTM within the framework of the provisions of the "Regulation on the Procedures and Principles Regarding Payments to Investors by the Investor Compensation Center Following the Partial Annulment of the Fourth Paragraph of Article 13 of the Capital Markets Law No. 6362" published in the Official Gazette dated September 7, 2016, and numbered 29824.

The relevant Regulation stipulates a two-stage application process: the first stage is the delivery of the physical shares/investment fund participation units to our Bank against a receipt; then, an application is made to the Investor Compensation Center with a copy of the delivery receipt and other necessary documents.

According to Article 5 of the aforementioned Regulation, the deadline for beneficiaries to apply to the Investor Compensation Center with the necessary documents is September 6, 2026.
